- Boutonniere's deformity
- PIP joint sprain
- PIP joint contracture
- Middle phalanx fracture



Mallet Finger Splint

- Mallet finger
- Distal phalanx fracture
- Fingertip injury with nail involvement

Wrist Cock-up Splint

- Carpal Tunnel
- Carpal Fracture
- Distal Radius Fracture
- TFCC tear
- Wrist sprain
- Wrist drop



Thumb Spica Splint

- Thumb CMC joint arthritis
- DeQuervain's tendonitis
- Intersection syndrome
- Post-op thumb CMC joint arthroplasty
- Scaphoid fracture



Short Opponens Splint

- Thumb CMC joint arthritis
- Thumb MCP joint injury



Dynamic Flexion Splint

- PIP or MP joint contracture



Ulnar Gutter Splint

- Metacarpal fracture of ring/small finger
- Proximal phalanx fracture of ring/small finger



Dorsal Blocking Splint

- Flexor tendon injury



Radial Gutter Splint

- Metacarpal fracture of index/long finger
- Proximal phalanx fracture of index/long finger



Long Arm Splint

- Cubital tunnel
- Elbow fractures

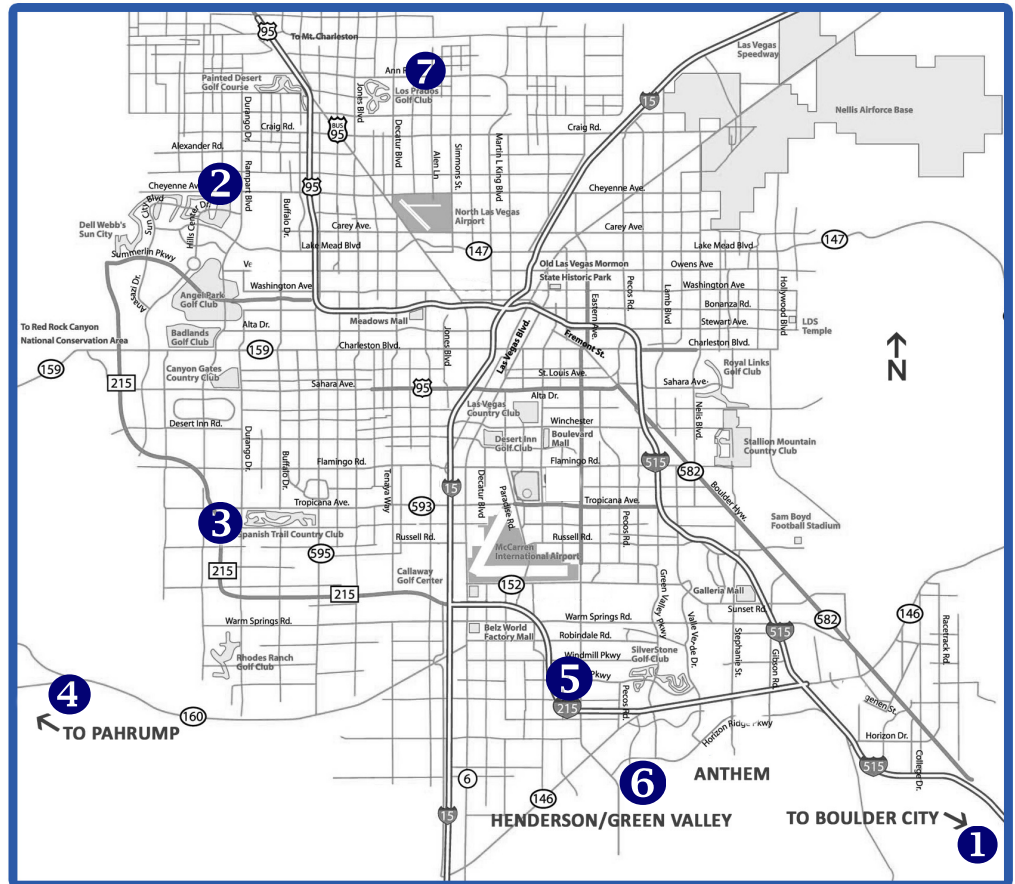
